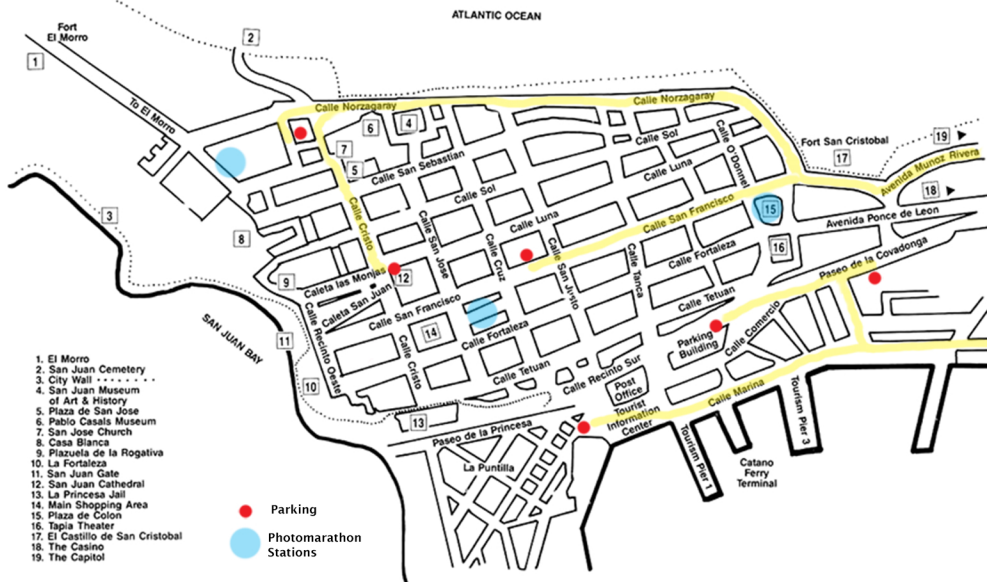

PARTICIPANT'S WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT
