## **CONTEST RULES AND SUBMISSION GUIDELINES**

- 1. YOU MAY WALK OR USE ANY OTHER METHOD OF TRANSPORTATION FOR THIS EVENT.
- 2. ALL PHOTOGRAPHS MUST BE TAKEN IN KEY WEST ON THE DAY OF THE EVENT BETWEEN THE HOURS OF 10:00AM AND 4:00PM.
- 3. PARTICIPANTS WILL HAVE SIX HOURS TO COMPLETE ONE(1) PHOTOGRAPH FOR EACH OF SIX (6) TOPICS, FOR A TOTAL OF SIX (6) IMAGES.
- 4. TO QUALIFY, PARTICIPANTS MUST DELIVER ALL SIX (6) IMAGES IN THE IN WHICH THE TOPICS WERE DIVULGED.
- 5. EXCEPT FOR THE FILE NAME, YOU ARE NOT PERMITTED TO AMEND ANY METADATA RELATED TO THE IMAGES. ANY ALTERATION OR SUSPECTED ALTERATION OF THE METADATA WILL COST THE ENTRY TO BE DISQUALIFIED. THIS DECISION WILL BE AT THE DISCRETION OF THE JUDGES AND/OR THE ORGANIZERS OF THE EVENT AND IS FINAL.
- 6. CONTESTANTS SHOULD BE IN KEY WEST BY 10:00AM WHEN THE FIRST TOPIC WILL BE DIVULGED VIA FACEBOOK, TWITTER AND INSTAGRAM.
- 7. THE REMAINING TOPICS WILL BE DIVULGED EVERY HOUR ON THE HOUR UNTIL 3:00PM.
- 8. PARTICIPANTS SHOULD HAVE ALL IMAGES COMPLETED BY 4:00PM.
- 9. COPYING OTHER PHOTOGRAPHS IS DISALLOWED (PICTURES OF OTHER PICTURES), EXCEPT THOSE SUCH AS ADVERTISING BILLBOARDS, BANNERS, ETC., INCLUDED IN PHOTOGRAPHS OF STREET SCENES.
- 10. ALL IMAGES MUST BE DELIVERED AS JPEG FILES.. RAW FILES WILL NOT BE ACCEPTED.

IN CONSIDERATION FOR RECEIVING PERMISSION TO PARTICIPATE IN THE SOUTH BEACH PHOTOMARATHON AND BY MAKING YOUR REGISTRATION PAYMENT YOU AGREE TO THE FOLLOWING:

### **RELEASE AND USAGE**

I HEREBY GRANT FOTOMISSION FOR THE PROMOTION OF FUTURE EVENTSTHE UNRESTRICTED RIGHT AND PERMISSION TO USE AND REUSE, PUBLISH, PRINT, AND REPRODUCE FOR DISPLAY, ANY PHOTOGRAPH IN WHOLE OR IN PART, COMPOSITE OR RETOUCHED IN CHARACTER OR FORM. I HEREBY RELINQUISH ANY RIGHT THAT I MAY HAVE TO EXAMINE OR APPROVE THE COMPLETED PHOTOGRAPHS, PRODUCT OR PRODUCTS OR PRINTED MATTER THAT MAY BE USED IN CONJUNCTION THEREWITH OR THE USE TO WHICH IT MAY BE APPLIED.

### PARTICIPANT'S WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

I RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE FOTOMISSION, THEIR DIRECTORS, OFFICERS, SERVANTS, AGENTS, OR EMPLOYEES (HEREINAFTER REFERRED TO AS RELEASES) FROM ANY AND ALL LIABILITY, CLAIMS, DEMANDS, ACTIONS AND CAUSES OF ACTION WHATSOEVER ARISING OUT OF OR RELATED TO ANY LOSS, DAMAGE OR INJURY, INCLUDING DEATH, THAT MAY BE SUSTAINED BY ME, OR TO ANY PROPERTY BELONGING TO ME, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASES OR OTHERWISE, WHILE PARTICIPATING IN THE PHOTOMARATHON, OR WHILE IN, ON OR UPON THE PREMISES WHERE THE ACTIVITY IS BEING CONDUCTED. FOTOMISSION SHALL HAVE NO RESPONSIBILITY FOR THE ACTS, ERRORS OR OMISSIONS OF STAFF, PERSONNEL OR ANYONE INVOLVED IN THE PHOTOMARATHON.

I AM FULLY AWARE OF ANY RISKS OR HAZARDS CONNECTED WITH THE PHOTOMARATHON, AND I ELECT TO VOLUNTARILY PARTICIPATE IN THE PHOTOMARATHON, AND TO ENGAGE IN SUCH ACTIVITY KNOWING THAT THE ACTIVITY MAY BE HAZARDOUS TO MY PROPERTY AND ME.

I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, THAT MAY BE SUSTAINED BY ME, OR ANY LOSS OR DAMAGE TO PROPERTY OWNED BY ME, AS A RESULT OF BEING ENGAGED IN THE PHOTOMARATHON, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASES OR OTHERWISE.

I FURTHER AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASES FROM ANY LOSS, LIABILITY, DAMAGE OR COSTS, INCLUDING COURT COSTS AND ATTORNEY FEES, THAT THEY MAY INCUR DUE TO MY PARTICIPATION IN THE ACTIVITY, WHETHER CAUSED BY NEGLIGENCE OF RELEASES OR OTHERWISE.

IT IS MY EXPRESS INTENT THAT THIS WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT SHALL BIND THE MEMBERS OF MY FAMILY AND MY SPOUSE, IF I AM ALIVE, AND MY HEIR'S ASSIGNS AND PERSONAL REPRESENTATIVE, IF I AM DECEASED, AND SHALL BE DEEMED AS A RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE THE ABOVE NAMED RELEASES. I FURTHER AGREE THAT THIS WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF FLORIDA.
